Countdown to Improved Crash Data Update on the new Wisconsin Crash Database and Crash Form August 2016 (Four months to go)

# Crash Form Training and Registration

As we have communicated in previous newsletters, we want to make sure that all the law enforcement agencies (LEAs) are trained on the new crash forms and are ready to use it beginning January 1, 2017. While this training is not mandatory, there have been significant changes to the forms, and training is strongly advised. Please find the training dates and locations below. Note: some new training sessions have been added. To further accommodate LEAs, the registration had been extended to September 4, 2016.

In addition to the above training, there will be presentations at The Governor's Conference on Highway Safety and at the TraCS User Conference. The TraCS User conference will also include break-out sessions during the day for discussion on the new crash forms.

# The Governor's Conference on Highway Safety

The 42<sup>nd</sup> Annual Governor's Conference on Highway Safety will be held next week, August 23-25 at the KI Convention Center in Green Bay. Please visit the <u>DOT website</u> for program details. It is not too late to <u>register online</u>.

#### The New TraCS Locator Tool

When the training version of TraCS is released in Fall 2016, the Incident Locator Tool (ILT) will be replaced with the TraCS Locator Tool (TLT). The TLT is no longer a separate application but is a part of TraCS. Badger TraCS is creating installations and documentation to coincide with the new tool. The TLT is similar to the ILT in appearance, though the puck is gone. New features include improved measurement functionality and the ability to locate using a Google Maps search.

## Driver Report Form – DT4002

In conjunction with the release of the new DT4000 Crash Report Form within TraCS, the DOT will be releasing the *Driver Report of Crash*, DT4002 to replace the MV4002, *Driver Report of Accident*. The DT4002 will be completed exclusively via a web application available at the DOT website. The application will include extensive help and validation tools to enable drivers to provide accurate crash information, significantly streamlining the filing and processing of these forms. We intend to provide informational cards to law enforcement that can be given to drivers, directing them to this form. Drivers without easy access to the web will be asked to visit their local library to access the form.

### **Further Developments**

As development of the crash forms nears completion, the Crash Database team is focusing its attention of reports or other materials that will be beneficial to the LEA community. One proposal is to have a secured web client where each agency can create custom searches of crash data. The team is interested in gathering suggestions on this idea, or any other idea, to get the data back into your hands.

#### Conclusion

Beginning on January 1, 2017, all crashes will be submitted electronically through a TraCS10 format. Neither the MV4000 nor the MV4002 will be available for paper submission for 2017 crashes.

Thank you for your partnership in transportation safety. Improved data will assist all of us with our data-driven approach to drive fatalities toward Zero in Wisconsin.
