Countdown to Improved Crash Data Update on the new Wisconsin Crash Database and Crash Forms September 2016 (Three months to go)

## Crash Form Training and Registration

As we have communicated in previous newsletters, we want to make sure that all the law enforcement agencies (LEAs) are trained on the new crash forms and are ready to use it beginning January 1, 2017. While this training is not mandatory, there have been significant changes to the forms, and training is strongly advised. Please find the remaining training dates and locations available for registration.

In addition to the above training, there will be presentations at the TraCS User Conference (November 3, 2016). The TraCS User conference will also include break-out sessions during the day for discussion on the new crash forms.

## Replicating Citations from the Crash Form

The new crash form features an improved flow for replicating citations from the crash form. The Law Enforcement Officer may initiate citations on the crash form by indicating whom the citation is to be issued to and the citation's Statute and Sequence numbers. These citations are now replicated as an integral step of crash form validation and are created with individual, statute, and crash data prepopulated from the crash form. Another new feature is that citations can now be issued to any unit occupant, not just drivers. The crash from can accommodate up to ten citations per individual and 99 citations per unit. As before, it is also possible to first create citations in TraCS and to then replicate from a citation to a crash form.

### Driver Report Form – DT4002

In conjunction with the release of the new DT4000 Crash Report Form within TraCS, the DOT will be releasing the Driver Report of Crash, DT4002, to replace the MV4002 (paper form), Driver Report of Accident. The DT4002 will be completed exclusively via a web application available at the DOT website. The application will include extensive help and validation tools to enable drivers to provide accurate crash information, significantly streamlining the filing and processing of these forms. It will also be mobile friendly, so that it can be easily completed on a smart phone. We intend to provide informational cards to law enforcement that can be given to drivers, directing them to this form. Drivers without easy access to the web will be asked to visit their local library to access the form.

### Further Developments

As development of the crash forms nears completion, the Crash Database team is focusing its attention on reports and other materials that will be beneficial to the LEA community and other stakeholders. One proposal is to have a secured web client where each agency can create custom searches of crash data. WisDOT is looking for suggestions on how to get the data back in your hands to maximize the use of the new form elements at the agency level. #### Conclusion

Beginning on January 1, 2017, all 2017 crashes will be submitted electronically through a new TraCS10 crash form. Neither the MV4000 nor the MV4002 will be available for paper submission for 2017

crashes.

Thank you for your partnership in transportation safety. Improved data will assist all of us with our data-driven approach to drive fatalities toward Zero in Wisconsin.
